NOTICE is hereby given that a telephonic special public hearing of the Monterey County Committee on School District Organization will be held on Monday, June 29, 2020, at 5:00 PM. In order to slow the spread of Coronavirus (COVID-19) pandemic, the Monterey County Committee on School District Organization is holding this public hearing telephonically in accordance with California Education Code Sections 35705 and 35705.5 and Governor Newsom's Executive Order N-29-20 for the purpose of taking public comment on the matter of the Petition of the Alisal Union School District, the Salinas Union High School District, and the Santa Rita Union School District, filed pursuant to Education Code Section 35700(D), proposing the transfer of territory from Santa Rita Union School District to Alisal Union School District and Salinas Union High School District (the Petition).

Members of the public who wish to comment on any item on the agenda may submit their public comment in writing to public-comment@montereycoe.org, no later than June 26, 2020 at 5:00 PM. Comments can also be mailed to the Monterey County Office of Education, 901 Blanco Circle, Salinas, CA 93901. All comments received by this time will be read into the record by the Committee chair. Please be aware that all written public comments, including your name, may become public information. Time limitations that are normally applied at our meetings will be applied to the reading of public comments. While efforts will be made by the chair to read all comments received into the record, we cannot guarantee that written comments received after June 26, 2020 at 5:00 PM or the reading of which extends beyond the time limits will be read.
