

SEXUAL HARASSMENT

The Monterey County Board of Education (Country Board) and the Monterey County Superintendent of Schools (County Superintendent) are committed to maintaining a safe school environment that is free from harassment and discrimination. Sexual harassment of students at school, school-sponsored, or school-related activities, at Monterey County Office of Education (MCOE) sponsored program activities or by cyber intimidation that can originate on or off the school site is prohibited. [Education Code (EC) 48900]

Sexual harassment includes rape, sexual assault, sexual battery, and sexual coercion, unwelcome sexual advances, or sexual intimidation. Regardless of whether a harassed student, their parent/guardian, or a third-party file a complaint under MCOE procedures or otherwise requests action on the student's behalf, a school employee who knows, or reasonably should know, about possible harassment must promptly take action to determine what occurred and then take appropriate steps to resolve the situation.

When a parent/guardian or student does not wish to disclose the student's identity, MCOE shall take steps to protect the identity of the student.

The County Superintendent or designee is obligated to investigate a complaint of sex discrimination and refer the incident to law enforcement as required by law. [EC 200-262.4]

The County Board and County Superintendent strongly encourage any student who has been sexually harassed on school grounds, at a school-sponsored program sponsored activity, or by cyber intimidation that can originate on or off the school site by another student or, to immediately contact their teacher, the principal, program administrator, or any other available school employee. Any employee who receives a report or observes an incident of sexual harassment shall notify the principal, program director, or the Chief Executive Officer Human Resources.

There shall be no retaliatory behavior or action against any person who reports, files a complaint or testifies about, or otherwise supports a complainant in alleging sexual harassment.
