Time limitations that are normally applied at our meetings will be applied to the reading of public comments. While efforts will be made by the chair to read all comments received into the record, we cannot guarantee that written comments received after November 7, 2021, at 5:00 PM or the reading of which extends beyond the time limits will be read.
