Williams/Valenzuela Legislation

- Williams Third Quarterly Report will be sent to districts in April 1213
- Date changed ~~May 13, 2013~~ for Williams Orientation to June 28, 2013. Reason for date change is due to the release of the list of schools subject to Williams visits for Fall 2013-2015 (Schools in API Deciles 1-3 are in the process of being determined by CDE and the *new* list of schools will be released tentatively in late June per CDE).

- Reminder AB1575

- AB 1575 Pupils Fees, restates existing law prohibiting a school from requiring a pupil to pay a fee, deposit or other charge not specifically authorized by law, for participation in an educational activity. **Beginning January 1, 2013**, AB 1575 provides that a complaint regarding pupil fees may be filed with the principal of a school under the Uniform Complaint Procedures (UCP). The complaint may also be filed anonymously. **On or before March 1, 2013** requires public schools to establish local policies and procedures to implement the provisions of AB 1575, LEAs must updated their UCP Annual Notice to include pupil fees information and must distribute notice to employees, pupils, parents/guardians, advisory committee members, private schools and other interested parties (see December Curriculum Council MCOE Web Page -December 7, 2012 Mtg. Handouts- *Instructional Materials and AB1575 Stu Fees*).
