c. Alisal Union School District Proposed Program Transfer

Gary Johnson, Director of Special Education Services at Alisal USD, gave a background on their proposed program transfer from current operation by MCOE to Alisal USD. The two classrooms are a continuum of moderate to severe classes that would continue to operate as a regional program. Phrani Diksa moved to approve that Kenyon Hopkins draft a letter of support from CAC to present to the SELPA Executive Committee and SELPA Governance Council for final approval, Anna Kauble seconded and the motion passed unanimously.

Kenyon Hopkins reported SELPA Program Specialists are continuing to work on the Professional Development Catalog offering current workshops at MCOE, training off-site at districts By Request, and building and adding new workshops with By Requests. Each workshop has an evaluation form, and presenters also meet afterwards to address feedback received.

Val Wiltse is making relations with special education directors, going out to sites and working on community based instruction programs. Anna Kauble is assisting districts with the implementation of Multi-Tiered Systems of Support (MTSS) focusing on academic interventions and the response to intervention.
